### SECRETARY'S REPORT:

Secretary Figone: The minutes went out last Sunday, there were a couple of corrections per Rolf Hill, I made the corrections and resent the minutes out, you have the corrected version, the corrections were spelling.

Our expenses were \$785.84 for printing, \$196.05 for postage and \$120.61 for envelopes and supplies for a total outflow of \$1,102.50 which leaves us with a balance of \$13,444.75 for the end of June. There is a deposit missing in the mail in the amount of \$296.00 that Bill sent to me, we will wait another week before we call the people that sent the checks to have them reissue another check and stop payment on the missing checks.

### SAFETY REPORT:

### MEMBERSHIP REPORT:

The total coming into the VKA will be \$875.00.
